MINUTES OF THE OICCI MANAGING COMMITTEE MEETING HELD ON TUESDAY, SEPTEMBER 24, 2024, AT 10:30 AM IN STANDARD CHARTERED BANK HEADOFFICE, KARACHI

- 1. President Rehan Shaikh welcomed the participants to the 12th MC Meeting of the term.
- 2. McKinsey benchmarking reports have been done on August 12, 2024.
- 3. OICCI is actively advocating for the swift resolution of Rs. 108 billion in pending income and sales tax refund claims with FBR and BOI. A formal letter was sent to FBR Chairman Rashid Mahmood Langrial on July 31, 2024.
- 4. OICCI submitted a detailed position paper to FBR Chairman on August 13, 2024, regarding the non-implementation of Advance Income Tax (AIT) on non-filer retailers.
- 5. SECP requested recommendations for improving shareholder meeting transparency; OICCI members' inputs have been forwarded.
- 6. OICCI launched the report Pakistan's Climate Crossroads: Private Sector Solutions to Pakistan's Climate Challenges on August 21, 2024, in partnership with SDPI, outlining a roadmap for public-private partnerships and sustainable solutions.
- 7. Under the ESG committee's theme 'Towards an Inclusive Green Economy,' four seminars have been conducted on Carbon Credits, Climate Governance, Climate Impact on Human Capital, and Green Financing prospects.
- 8. Dr. Abid Qaiyum Suleri led an ESG session on August 21, 2024, addressing sustainability challenges, carbon emissions, and balanced ESG approaches.
- 9. OICCI hosted a session on Climate Governance with Aucky Pratama of ACCA on September 13, 2024, discussing frameworks for managing climate risks and promoting sustainable business practices.
- 10. OICCI held a session on July 11, 2024, to explore the potential of AI in enhancing business growth and productivity, continuing efforts to help businesses harness AI through knowledge dissemination.
- 11. OICCI participated in ITCN Asia 2024, held at Expo Centre Karachi from August 27-29, reaffirming its commitment to advancing Pakistan's IT and Telecom sectors. OICCI President Rehan Shaikh gave the keynote address at the conference.
- 12. Held a security session titled "Agile Security Management for Modern Corporate Challenges" on August 1, 2024, with 43 participants (both in-person and online).
- 13. DG FIA Ahmad Ishaque Jehangir visited OICCI on August 28, 2024, to discuss issues concerning the FIA with members.
- 14. July 10, 2024: Pharma Bureau (PB) met with the Prime Minister's Health Coordinator to discuss Drug Act amendments, PIC-GMP practices, and bioequivalence studies, engaging further with DRAP's CEO.
- 15. August 5, 2024: PB presented to DRAP's Policy Board, advocating for amendments to the Drugs Act to decriminalize provisions, attract investment, and improve the sector's image, also highlighting CPI letters and deregulation.

- 16. August 9, 2024: PB sent a letter to the Prime Minister outlining industry challenges and proposing solutions.
- 17. August 22, 2024: TDAP facilitated a meeting with PB and PPMA, where industry concerns were highlighted, and collaboration with the Ministry of Commerce to address these issues was agreed upon.
- 18. PB and PPMA met with Punjab Health Minister Imran Nazir on September 10, 2024, agreeing to review penalties under Section 27 of the Drugs Act and submit industry proposals.
- 19. ED PB attended a networking dinner with the US consulate's Economic Team on September 11, 2024, followed by a meeting with Kevin Furey, Economic Unit Chief, to discuss industry challenges and pursue greater stakeholder collaboration.
- 20. The MC was presented with the ESG subcommittee's action plan for the next half year, which included the schedule for the 3rd Pakistan Climate Conference (January 28-29), the plan for participation in the COP29 side event (November 11-12, 2024, in Baku), the proposed partnership with SDPI, the commitment to participate in the SDPI Sustainability Conference (November 6), and the related member communications.
- 21. The results of OICCI Ease of Doing Business Survey 2024 were presented to MC.
- 22. The results of OICCI Export Survey 2024 were presented to MC.
- 23. The MC was informed that OICCI Newsletter covering activities of the Chamber from January 2024 till July 2024 was released to members in August 2024.
- 24. Polling for the MC election 2024-26 concluded on September 16, 2024, while polling for office bearers was scheduled for September 23, 2024. The results of the election 2024-26 will be announced at the EOGM on September 30, 2024, at 2:30 pm.
- 25. The MC approved the admission of Karachi Hydrocarbon Terminal Limited as members of OICCI. After approval of the above, the total membership has gone up to 212.
- 26. The MC was informed that out of the total annual subscription of Rs. 178 million (including the revised fee approved by members in the 164th AGM), Rs. 149.6 million (84%) has been received. Reminders have been sent to the members.
- 27. The MC ratified and approved the following two circular resolutions:
 - Circular resolution dated July 25, 2024, for Proposed Plan of Activities 2025-27.
 - Circular resolution dated August 13, 2024, for fixing the number of MC seats for 2024 elections.
- 28. The next MC meeting is scheduled in November 2024.
